Waiver: (Read carefully before signing): A physical examination is not required to compete in the Trail Half Marathon. This race is characterized by high elevation, big hills, extreme distances, uneven terrain, roots, rocks, sand and general trail conditions found in a forest/desert. It may be hot, cold, wet, snowy, windy and generally stormy. You may encounter deadly snakes or animals and other hazards. If I participate I could die or be seriously injured. Having considered all the options, I agree to participate at my own risk. In consideration of my (or if the participant is a minor, the minor*s) entry and/or participation in the Fall/Spring Trail Half Marathon and associated events, I do hereby release, discharge, hold harmless, indemnify, acquit, and promise not to sue Cat Foot Racing (Ott Wischki), Catalina Foothills Fitness (CFF), its agents, employees, race officials, sponsors, Town of Marana, The US Forest Service and volunteers from any and all claims of damage, causes of action, suit, costs, charges, claims, demands and liabilities of whatever kind, name, or nature in any manner arising out of my (or if I am signing as parent or legal guardian of a minor, the minor's) participation or involvement in said race and associated events. This release extends to all claims of every kind or nature whatsoever, foreseen or unforeseen, known or unknown. This release is intended to cover all non-fatal or fatal injuries and illnesses of any kind or nature which may be sustained or suffered from any cause whatsoever connected or arising out of the participation in, or involvement with, the Fall/Spring Trail Half Marathon and associated events.

I, the undersigned, know that the Trail half Marathon and training runs are events which carry the risk of personal injury. I agree that I, as either a participant or legal guardian of a participant who is a minor, must take an active role in understanding and accepting these risks, conditions and hazards, and I attest and verify I have full knowledge of the risks involved in such events.

I also agree that I, and not the race officials, volunteers, Cat Foot Racing (OPW), CFF, sponsors or others associated with the event, am responsible for my (or if I am signing as the legal guardian of a minor, the minor's) safety while I (or the minor) participate or train for these events. Minimum age is 16 years old as of December 31st 2012.

Further, I agree that if the race is canceled or postponed, I am responsible for any costs I have incurred to attend the race, including travel expenses.

I hereby grant full permission for Cat Foot Racing or its designated agents to use any photographs, videotapes, recordings, or any other record of these events for any purpose without compensation.
